Sl. No.	The school is directed to ensure that :
1	The total number of sections for Bal Vatika is restricted to 03 (01 each for Bal Vatika I,II & III respectively). Further, the total number of sections for classes 1st to 10th shall be restricted to 12 only. The optimum number of the students shall be restricted to 40 in each section. Any further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of 500 sq ft and greater in dimension.

2	The school should upgrade the composite Science lab with proper safety measures and recommended infrastructure as per SoPs and Board guidelines notified vide circular no 11/2022. The acids and chemicals are placed in open rack without locked stock area and only one exhaust fan and one fire extinguisher is available. School is directed to upgrade the lab as per board guidelines and upload the compliance on SARAS portal within 03 months with video link.
3	Math lab is seen with small tables as work stations which are not sufficient and suitable for project/practical works. Math lab is mandatory as per rule 4.5 of the affiliation bye laws and should be arranged as per circular no 11/2022 with all recommended infrastructure and facilities. School is directed to upgrade the same and upload the compliance of SARAS portal within 03 months.
4	Library is under stocked and the books are arranged in open iron racks without proper categorization for smooth library function. Further, more library stocks on child age specific books and as recommended vide circular no 11/2022 (SoPs on library) be included. School is directed to enrich the library with recommended stock and infrastructure as per guidelines and upload the compliance on SARAS portal within 03 months with book procurement receipts and video link.
5	The CWSN toilets separately for boys and girls are not available at each floors with all recommended facilities and infrastructure as per statutory provisions of the RPwD, Act and guidelines as notified vide Board circular no 05/2023. The toilets should have proper ramps with entrance and proper space to navigate and movement of wheelchair inside. School is directed to make such mandatory provisions and upload the compliance on SARAS portal within 03 months with video link.
6	School shall ensure and strictly comply with the safety measures for the students and staff and notified by statutory provisions and the guidelines issued by the board from time to time and shall upload the affidavit on the same on SARAS portal within 03 months.
7	School shall ensure the mandatory training of its teachers from CoE, CBSE, Bengaluru and shall upload the compliance on SARAS portal within 03 months.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.

5. The school shall renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
